1.0 QUALIFICATIONS

- 1.1 I am a practicing Landscape Architect working as the Regional Director and Office Lead for the NAK Design Strategies Ottawa location. I have more than 19 years of experience practicing Landscape Architecture in the Toronto and Ottawa areas. During this time, I worked for a 10-year term (2009-2019) with the City of Ottawa's Planning Department and Parks and Recreation Department as a Senior Park Planner. In that role, I worked in Development Review and was responsible for acquiring new growth-related parks for the City of Ottawa and overseeing park design and development. I have worked extensively on the City's Park Development Manual, Building Better and Smarter Suburbs policy (specifically parks and stormwater management), subdivision and site plan conditions regarding parkland, and the overall park development process, including developer-built parks, capital park projects, and parkland acquisitions across the City in the urban, suburban, and rural wards.
- 1.2 Attached to this Witness Statement is a copy of my *Curriculum Vitae*, together with a signed Acknowledgement of Expert's Duty.

2.0 RETAINER

2.1 In 2020, I was asked to review preliminary engineering drawings and provide comments on the existing and proposed servicing and emergency overflow routes that were identified in the park blocks and elaborate, from a Park Planner's perspective, on how they might impact the current and future design and development of the parks.

3.0 SUMMARY OF EVIDENCE AND OPINIONS

3.1 Below are the issues from Attachment 3 - Issues List from the Procedural Order (dated: November 3rd, 2020) that I will speak to:

3.2 Kanata Greenspace Protection Coalition

Conformity with the Planning Act

27. Does the proposed zoning amendment have appropriate regard to Section 2 with particular reference to Subsections (a), (h), (i), (o), (p) and (r)?

Subsection 2(i) of the Planning Act states that a matter of provincial interest is "the adequate provision and distribution of educational, health, social, cultural and recreational facilities".

3.2.1 In my opinion, the proposed greenspace network provides a variety of park typologies, including a neighbourhood park, a woodland park, and two (2) parkettes, that contribute to improving the overall open space network and ensures adequate and accessible greenspace for both new and existing residents living within a 5-minute walk (400m radius) as stated in Policy 2.4.5.8 of the City of Ottawa Official Plan (May 2003). Additionally, the preservation of mature tree stands and significant woodlots provide greater open space diversity, have ecological benefits, and contribute to educational, health, social, cultural, and recreational opportunities within the proposed redevelopment. Park amenities in the overall open space network, existing and proposed, provide a range of both active and passive recreational opportunities that include sports fields, tennis courts, swimming pools, splash pads, playgrounds, outdoor fitness stations, recreational trails, preserved woodlots, and gathering spaces; supported by existing community facilities such as schools, libraries, and community centres. Please see Parks, Open Spaces & Natural Features (pg. 24) of the Urban Design Brief (June 2021) for existing and proposed parks programming, ponds, open spaces and natural feature locations, and landscape buffers.

3.3 Kanata Greenspace Protection Coalition

Conformity with the Official Plan

34. Is the proposed zoning amendment and plan of subdivision in general conformity with the Official Plan with particular reference to the following sections:

(c) 2.4 / 2.4.5 – Maintaining Environmental Integrity / Greenspaces

- 3.3.1 In my opinion, the proposed greenspace contributes to and creates a "sense of place" and provides "physical boundaries, features, and buffers within and between communities" (Section 2.4.5 of the City of Ottawa Official Plan, 2003).
- 3.3.2 The proposed plan has a variety of greenspaces, including enhanced landscape buffers, stormwater management (SWM) facilities, parkettes, a woodland park, a neighbourhood park, and numerous open space blocks, that preserve existing natural features, such as significant woodlots, treed areas, rock outcrops, and natural drainage courses, and contribute to the overall character of the site and serve the outdoor needs of residents. These outdoor public spaces, and the surrounding existing greenspaces, will be connected by a series of linkages, sidewalks, trails, and pathways from both the existing and proposed neighbourhoods. Please see Figure 37 | Trails Network Plan (pg. 29) of the Urban Design Brief (June 2021).
- 3.3.3 With the City and its residents valuing mature trees, the proposed plan includes 6m landscape buffers for the protection and preservation of existing trees and identifies areas of tree retention in parks and open spaces. New trees will be planted to replace any trees that have been removed to accommodate the proposed plan. New plantings will also be included within the 3m landscape buffers to ensure appropriate screening and separation between new and existing rear yards abutting one another. Please see Parks, Open Spaces & Natural Features (pg. 24) and Gateway Features & Edge Conditions (pg. 44) of the Urban Design Brief (June 2021) for park and buffer demonstrations.
